Conditions to pass 1st and 2nd enrolments:

- For Social Morals:

- •The content of the course is divided into four blocks that will be evaluated during the semester according to the calendar that will be available at the beginning of the semester through the internet.
- ·In order to take every assessment tool into account, it will be necessary to have reached, at least, a 4,5 score on each of this four tests.
- ·At the end of the semester students will have the opportunity to repeat a maximum of two of these tests in order to better their score.
- ·Should a student have more than two partials exams due, he or she will necessarily take the final exam in the second examination session (special call will be made for these cases).
- •An outstanding class participation might better the results of the partial evaluation by up to one point (given that they have reached at least a 4.5). at the end of the semester, and during the official examination period, a final –always in-class- exam of around 60 minutes of duration will take place, in which at least a 5,00 score has to be reached.
- •The course will be considered a successful studied if the mean between the four block-evaluations and the final exam is at least of 5,00.
- •The specific contend of each block and of the final exam will be detailed at the beginning of the semester though the intranet/virtual platform.
