Observations

1ª) Es imprescindible obtener un mínimo de 5 sobre 10 en el examen (que será tipo test) para poder computar o valorar los otros dos instrumentos de evaluación (por un lado, "asistencia, participación activa y actitud favorable en la asignatura" y, por otro lado, "pruebas prácticas") en 1ª convocatoria. 2ª) En relación con el concepto de "asistencia, participación activa y actitud favorable en la asignatura" (20%), la mera asistencia o presencia física a las clases computará un máximo de un 5%, mientras que el 15% restante derivará de la actitud favorable en la asignatura mostrada de alguna de las siguientes formas: ·Las intervenciones de los estudiantes en las propias clases (presenciales u online), con los registros o anotaciones correspondientes. ·Las tutorías virtuales a través del Campus virtual UCVnet o las sesiones online a través de Teams desarrolladas como una tutoría de forma grupal o individual. ·Las intervenciones en el foro creado en la plataforma UCVnet para plantear y responder a dudas del temario. ·Los correos electrónicos o mensajes recibidos planteando cuestiones sobre el temario de la asignatura. 3ª) Sólo si la nota final es igual o superior a 5, se aprobará la asignatura. Ello tanto en 1ª como en 2ª convocatoria.



No obstante, en caso de que el estudiante obtenga una nota total próxima al aprobado en 2ª convocatoria, podrá superar la asignatura si el profesor lo considera correcto teniendo en cuenta intervenciones destacadas del alumno en cuestión a lo largo del cuatrimestre.

4ª) Acorde al artículo 9 de la Normativa General de Evaluación y Calificación de las Enseñanzas Oficiales y Títulos Propios de la UCV, el sistema de evaluación continua es el sistema preferente de evaluación en la UCV. El art. 10 permite no obstante, para aquellos estudiantes que, de forma justificada y acreditada, no puedan someterse al sistema de evaluación continua, y así lo soliciten al profesor responsable de la asignatura, quien decidirá expresamente sobre la admisión de la petición de evaluación única del estudiante y se le comunicará la aceptación/denegación. Por lo que a la asignatura de Derecho Administrativo Económico se refiere, el porcentaje de asistencia mínima requerido es del 70%, siendo pues este el límite a tener en consideración para la potencial solicitud de evaluación única. Esta, en caso de ser concedida, se articulará en base a los siguientes criterios: ·En primera convocatoria, el porcentaje correspondiente a asistencia y participación en clase, acrecerá el porcentaje de las prácticas (10%) y de la prueba final teórica (10%) realizada en período oficial de exámenes. 5º) El alumnado podrá usar la IA para cualquier consulta relacionada con la asignatura e, incluso, proveerle de enunciados, prácticas o pruebas de evaluación para obtener respuestas automáticas, siempre y cuando éstas sean contrastadas y validadas por el propio estudiante. Criterios de cita y atribución: ·Toda utilización de herramientas de IA deberá estar declarada de forma explícita en el documento entregado (p. ej., en una nota al pie o en un anexo). ·Se indicará el nombre de la herramienta, el propósito de uso (ej. revisión gramatical, organización de ideas, ejemplo de redacción) y en qué parte del trabajo se ha empleado. ·El uso responsable de la IA se evaluará como parte de los criterios de originalidad y honestidad académica.
