Observations

The final written test, both theoretical and practical, may contain multiple-choice questions and short open-ended questions. To pass the course, it is required to obtain at least 40% of the maximum grade in both the theory and practical exams, so that they can average with the rest of the evaluable sections. The Delivery of Works (20% of the final grade) will consist of the following:

- 1. Laboratory notebook (5% of the final grade). The delivery will be made through a task enabled in the Platform of the subject. The grade must be at least 50% in order to average with the other evaluable sections.
- 2. Group Work on a topic from a list proposed by the professor (10% of the final grade). Both a written document in Word format and a PowerPoint file will have to be presented in class. The delivery of the two files of the work will be done through a task enabled on the Platform for this purpose. The Group Work must be passed with a grade of 50% to average with the other sections.
- 3. Platform Questionaries (5% of the final grade). The questionaries may contain both multiple choice questions and short answer questions.
- Criteria for granting honors: According to the general regulations, only one honor degree can be awarded for every 20 students, not for a fraction of 20, with the exception of the case of groups of less than 20 students in total, for which a single honors degree will be awarded. In addition, according to the agreement of the Facultyof January 26, 2010:
- Honors may only be awarded on the first or second call of the student's first year of enrollment in the subject. The professor may grant honors only to students who have obtained an A grade (90% or higher) in the subject.
- In the event that the final grade of two students is similar, the grades obtained in the final exam will be used as discriminating criterion. If these were also similar, the grades of the Group Work, the Platform Questionaries and the Laboratory Notebook would be considered in this order.

MENTION OF DISTINCTION:

According to Article 22 of the Regulations governing the Evaluation and Qualification of UCV Courses, the mention of "Distinction of Honor" may be awarded by the professor responsible for the course to students who have obtained, at least, the qualification of 9 over 10 ("Sobresaliente"). The number of "Distinction of Honor" mentions that may be awarded may not exceed five percent of the number of students included in the same official record, unless this number is lower than 20, in which case only one "Distinction of Honor" may be awarded.

- M5 Application of multidisciplinary knowledge.
- M6 Personalized and small group attention. Period of instruction and/or guidance carried out by a tutor to review and discuss materials and topics presented in classes, seminars, readings, papers, etc.
- M7 Set of oral and/or written tests used in initial, formative or additive assessment of the student
- M8 Group preparation of readings, essays, problem-solving, seminars, papers, reports, etc. to be presented or submitted in theoretical, practical and/or small-group tutoring sessions. Work done on the university e-learning.
