MINIMUM GRADE CRITERIUM IN THE FINAL EXAM: It will be necessary to obtain, at least, a 4 in the exam in order to apply the percentages obtained from the grades of the practical part and the part related to class attendance, and thus obtain the final grade of the subject that must be equal or superior to 5. OTHER CRITERIA TO BE CONSIDERED: For the second call the practical assignments submitted and the attendance and participation in class will be kept and taken into account to the same extent and percentage. The practical assignments delivered after the due date will only account for half of the total grade assigned to them. Regarding attendance and participation, attendance will account for 10 percent of the grade, and participation for the other 10 percent. If any student detects an error in the evaluation of attendance on the platform, he or she must tell the professor within the following ten days.

MENTION OF DISTINCTION:

According to Article 22 of the Regulations governing the Evaluation and Qualification of UCV Courses, the mention of "Distinction of Honor" may be awarded by the professor responsible for the course to students who have obtained, at least, the qualification of 9 over 10 ("Sobresaliente"). The number of "Distinction of Honor" mentions that may be awarded may not exceed five percent of the number of students included in the same official record, unless this number is lower than 20, in which case only one "Distinction of Honor" may be awarded.

Learning activities
