Observations

All of this in accordance with the general regulations which indicate that only one honoursone honourable mention for every 20 students, not for a fraction of 20, with the exception of groups of less than 20 students in the case of groups of less than 20 students in total, in which one honourable mention may be awarded.

CRITERIA FOR THE FINAL GRADE: A 5 in the final exam will be necessary in order for the percentages obtained in the final exam to be applied the percentages obtained from the marks of the practical part, as well as those obtained for attendance and participation, will be applied.obtained for attendance and participation in class and, thus, obtain the final mark for the course, which will obviously have to be equal to or higher than 5.

In accordance with article 9 of the General Regulations on Assessment and Grading of UCV Official Studies and UCV-specific degrees, the continuous assessment system is the preferred system of assessment at the UCV.

However, art. 10 allows, for those students who, in a justified and accredited manner, show their inability to attend in person (or to synchronous communication activities for virtual and/or hybrid teaching modalities), their extraordinary assessment in the so-called single assessment. This single assessment must be requested within the first month of each semester to the Dean's Office of the Faculty through the Vice-Dean's Offices or Master's Degree Departments, with the latter being responsible for the express decision on the admission of the student's request.

For the subject of DOCUMENTSCOPIA AND GRAPHOLOGY, the evidence to be presented and/or the test/s to be taken in the single evaluation by the student are established according to PRACTICES SUBMITTED (50%) EXTRA PRACTICES TO COMPENSATE PART OF THE ATTENDANCE PERCENTAGE (15%) AND FITNAL TEST EXAM (35%)

OBSERVATIONS: For those students who do not pass the course in the first exam, in order to pass the course in the second exam, subject in the second call may occur in two cases:--- students who pass the final exam, but after adding the 3 evaluable parameters (practical, students who do not achieve a 5 in the final exam.--- students who have passed the practicals but do not achieve a 5 in

the final exam. In the first case, students will have to take a practical exam in the second call, which will consist of one or several practical cases to be carried out in full in writing (which may be on any of the subjects of the deal with one of the topics of the practicals that have been carried out during the course e.g. preparation of an expert report on forgery of documents, an expert graphoscopic report, a description of handwriting, etc.). description of handwriting, etc.). You must obtain at least a 5 in order to proceed to the sum of the 3 evaluable parameters (final exam, practical exam and attendance-participation). The course will be passed when the total final grade is 5 or higher. In the second case, students will sit a new multiple-choice exam of 50 questions on the theoretical content of the course. on the theoretical content of the subject, having to obtain at least a 5 in this exam in order to proceed to the Sum of the 3 evaluable parameters (final exam, practical exam and attendance-participation). The course will be passed when the total final grade is 5 or higher. All of them, if they do not pass the course in the second sitting, will sit the exam in the extraordinary sitting. will be examined in two parts: a first part consisting of a 50-guestion multiple-choice exam on of 50 questions on the theoretical content and one or more practical cases to be completed in full in writing (which may be on the theoretical content). (which may deal with any of the topics of the practical exercises that have been carried out during the course, e.g.: 'preparation of an expert report on forgery of documents, an expert graphoscopic report, an expert forgery expert report, a handwriting description...).In order to pass the course and take the average, it will be necessary to obtain a minimum of 5 points in each of the exams.

CLASS ATTENDANCE IN FACE-TO-FACE DEGREES

In accordance with the development guidelines of the General Regulations for the Evaluation and Qualification of Official Teachings and Own Degrees of the UCV, in face-to-face degrees, class attendance with a minimum of 80% of the sessions of each subject will be required as a requirement. to be evaluated. This means that, if a student does not attend the sessions of each subject, in a percentage greater than 20%, he/she will not be able to be evaluated, neither in the first nor in the second call, unless the person responsible for the subject, with the approval of the person responsible for degree, in view of duly justified exceptional circumstances, exempt from the minimum attendance percentage. The same criterion will be applicable for hybrid or virtual degrees in which teachers must maintain the same percentage in the requirement of "presence" in the different training activities, if any, even if these are carried out in virtual environments.

MENTION OF DISTINCTION:

The mention of "Honors" may be awarded to students who have obtained a grade equal to or greater than 9.0. Their number may not exceed five percent of the students enrolled in a group in the corresponding academic year, unless the number of students enrolled is lower.





Learning activities

The following methodologies will be used so that the students can achieve the learning outcomes of the subject:

- M1 Presentation of contents by the teacher, analysis of competencies, explanation and demonstration of abilities, skills and knowledge in the classroom.
- M2 Specific instructions about group and individual assignments for each topic.
- M3 Group work sessions supervised by the teacher. Study of legal cases, both real and fictitious, analysis, diagnosis, problems, field study, computer room, visits, data search, libraries, network, Internet, etc. Significant construction of knowledge through student interaction and activity. Critical analysis on values and social commitment.
- M4 Application of interdisciplinary knowledge.
- M5 Supervised monographic sessions with shared participation
- M6 Personalized attention and in small groups. Period of instruction and/or orientation carried out by a tutor with the objective of reviewing and discussing the materials and topics presented in the classes, seminars, readings, completion of assignments, etc.
- M7 Set of oral and/or written tests used in the initial, formative or summative evaluation of the student.
