Observations

Continuous assessment requires a minimum attendance of 60% of the sessions.

According to Article 9 of the General Regulation on Evaluation and Certification of Official Teaching and Own Degrees of UCV, the unique evaluation is linked to the impossibility of attendance of the enrolled students in a face-to-face degree. It is, therefore, an extraordinary and exceptional evaluation system to which only those students who can prove that they cannot undergo continuous evaluation and formally request it from the responsible professor can adhere, who will expressly decide on the appropriateness of the request, subsequently communicating the acceptance/denial. If this is accepted, it will be articulated as follows:

- in the case of the 1st call: the 10% corresponding to attendance, active participation, and a favorable attitude towards the subject will increase the final percentage of the theoretical tests (by 5%) and practical (by 5%) carried out in the official exam period;
- in the case of the 2nd call: the same evaluation criteria will be applied to those who present themselves as to those students who have recognized the unique evaluation (since attendance, active participation, and a favorable attitude towards the subject will not be taken into account for them).

Passing the subject of Legal Sociology requires passing the theoretical test, conducted in the official exam period. The development of this subject does not foresee the use of any type of AI for



the completion of practical work, assignments, and evaluation tests.

MENTION OF DISTINCTION:

The mention of "Honors" may be awarded to students who have obtained a grade equal to or greater than 9.0. Their number may not exceed five percent of the students enrolled in a group in the corresponding academic year, unless the number of students enrolled is lower.
