Observations

1st) It is essential to obtain a minimum of 5 out of 10 in the exam to be able to compute or evaluate the other two evaluation instruments (on the one hand, "attendance, active participation and favorable attitude in the subject" and, on the other hand, "tests practices") in 1st call. In 2nd call, only the exam grade will be taken into account, not taking into account the practices delivered, the practical tests or questionnaires carried out in the classroom or, in principle, the attendance and participation of the student throughout the semester.

2nd) In relation to the concept of "attendance, active participation and favorable attitude in the subject" (15%), the mere attendance or physical presence at the classes will compute a maximum of 5%, while the remaining 10% will derive from the favorable attitude in the subject shown in one of the following ways:

- 1-The interventions of the students in the classes themselves (in person or online), with the corresponding records or annotations.
- 2-Virtual tutorials through the UCVnet virtual Campus or online sessions through Teams developed as a group or individual tutorial.
- 3-The interventions in the forum created on the UCVnet platform to raise and answer questions on the agenda.
- 4-Emails or messages received raising questions about the subject matter.
- 3rd) Only if the final grade is equal to or greater than 5, the subject will be approved. This both in 1st and 2nd call. However, if the student obtains a total mark close to the one approved in the 2nd call, he may pass the subject if the teacher considers it correct, taking into account the outstanding interventions of the student in question throughout the semester.

MENTION OF DISTINCTION:

According to Article 22 of the Regulations governing the Evaluation and Qualification of UCV Courses, the mention of "Distinction of Honor" may be awarded by the professor responsible for the course to students who have obtained, at least, the qualification of 9 over 10 ("Sobresaliente"). The number of "Distinction of Honor" mentions that may be awarded may not exceed five percent of the number of students included in the same official record, unless this number is lower than 20, in which case only one "Distinction of Honor" may be awarded.

Learning activities

The following methodologies will be used so that the students can achieve the learning outcomes of the subject:

- M1 Group work sessions supervised by the teacher. Study of legal cases, both true and fictitious. Significant construction of knowledge through student interaction and activity. Critical analysis of values and social commitment.
- M6 The student must present a case in which the applicable law is not the national law but the Community or international law directly.
- M7 The students must read some specific texts that are connected with the module and be able to present their conclusions.
- M8 Exposition of contents by the teacher, analysis of competences, explanation and demonstration of capacities, skills and knowledge in the classroom.
- M11 Personalised attention and in small groups. Period of instruction and/or orientation carried out by a tutor with the aim of reviewing and discussing the materials and topics presented in the classes, seminars, readings, completion of assignments, etc.
- M12 Set of written and/or oral tests used in the initial, formative or summative evaluation of the student.
- M13 Group preparation of readings, essays, resolution of problems, seminars, papers, dossiers, etc., to be presented or delivered in theory classes, practical classes, and/or small group tutorials.
- M14 Student's study: individual preparation of readings, essays, problem-solving, seminars, works, reports, etc. to present or deliver in the theoretical classes, practical classes and/or small group tutorials.

- Regarding attendance, being the classes online, attendance is not mandatory (although it is convenient) and mere attendance will not count towards the final grade. Consequently, attendance is not recorded. The percentage of punctuation foreseen for the mere attendance (5%) will increase the percentage of participation and favorable attitude in the subject (the percentage of this will be, therefore, in total, 15%). In other words, since the classes are online, only the participation of the student will be taken into account (in addition, of course, the percentage corresponding to the practices and the exam).

However, in order not to harm the students and in order to respect the corresponding percentages indicated in the teaching guides (in accordance with the academic report) while there are applicable results, the percentage corresponding to the mere attendance of the face-to-face classes will be considered until now.

- Regarding the final exam (to be carried out within the official exam period), it will be theoretical-practical and in writing, as planned from the beginning of the course. The difference with respect to what was initially planned is that it will be done online through the UCVNet platform (moodle).

The exam will be two questions to develop theoretical-practical in writing with one hour of duration on the contents developed in the matter, via the UCVNet platform.
