Students must have passed at least the 48 ECTS of Basic Training of the first two semesters. Students are free to choose the electives they wish, breaking with the grouping proposed. As explained above, the Study Plan has three optional subjects that are grouped in this way:

- 1 optional subject in the seventh semester.
- 2 optional subjects in the eighth semester.



Learning outcomes

At the end of the course, the student must be able to prove that he/she has acquired the following learning outcomes:

- R1 To have a global vision about the process of construction of Europe, understanding its historical reason.
- R2 The student will know the main characters of the 20th century related to the construction of the European project.
- R3 To know the different historical stages that have led the European society to integrate into supranational institutions.
- R4 To understand the need to create a sense of belonging to the European project and its evolution towards European citizenship.
- R5 To know and understand the implications that the project of European construction has had on the States that make up the current European Union and to obtain the specific skills to include the approach of comparative law in their legal analyses.
- R6 In relation to the previous one, to know the specific implications that the process of European construction has had for Spain and its evolution towards such integration.
- R7 The student will handle the concepts related to the process of European construction and the specific vocabulary of Community law or Community jargon so that he or she will be able to understand and analyze correctly the texts issued by the Community institutions.
- R8 To know the implications of the European construction in relation to third states and the vision that third states have of the European block.
- R9 The student will have a general knowledge of the main doctrine on the process of European construction, both from national and foreign authors, as well as the main currents of thought related to the common European project, both critical and Europeanist voices.
- R10 To have sufficient knowledge of the process of European construction, its historical evolution and current events to be able to form their own opinion on this process and to be able to accurately analyse news related to Europe, as well as the implications in current Spanish and European society.

Observations

1ª) Students must obtain a minimum of 5 points out of 10 in the theoretical exam and in the practical exam to make the average and to be able to sum the other assessment instruments. However, in the 2nd call, the practices presented throughout the course will not be taken into account, neither the assistance and participation. The student must do a practical questionnaire and a theoretical questionnaire the same date of the official exam. The mark obtained in said tests will represent 100% of the final grade (50% theoretical and 50% practical).

2ª) In relation to the concept of "attendance, active participation and a favourable attitude in the subject" (40%), the mere attendance or physical presence at classes will compute a maximum of 10%, while the remaining 30% will derive from the favourable attitude in the subject. The assessment will be made through the records of attendance and the quality of the participation.

3ª) Students must obtain a minimum of 5 points out of 10, both in 1st or 2nd call, to pass the subject.

MENTION OF DISTINCTION:

According to Article 22 of the Regulations governing the Evaluation and Qualification of UCV Courses, the mention of "Distinction of Honor" may be awarded by the professor responsible for the course to students who have obtained, at least, the qualification of 9 over 10 ("Sobresaliente"). The number of "Distinction of Honor" mentions that may be awarded may not exceed five percent of the number of students included in the same official record, unless this number is lower than 20, in which case only one "Distinction of Honor" may be awarded.



Learning activities

The following methodologies will be used so that the students can achieve the learning outcomes of the subject:

- M1 Group work sessions supervised by the teacher. Study of legal cases, both true and fictitious. Significant construction of knowledge through student interaction and activity. Critical analysis of values and social commitment.
- M8 Exposition of contents by the teacher, analysis of competences, explanation and demonstration of capacities, skills and knowledge in the classroom.
- M9 Supervised monographic sessions with shared participation.
- M11 Personalised attention and in small groups. Period of instruction and/or orientation carried out by a tutor with the aim of reviewing and discussing the materials and topics presented in the classes, seminars, readings, completion of assignments, etc.
- M12 Set of written and/or oral tests used in the initial, formative or summative evaluation of the student.
- M13 Group preparation of readings, essays, resolution of problems, seminars, papers, dossiers, etc., to be presented or delivered in theory classes, practical classes, and/or small group tutorials.
- M14 Student's study: individual preparation of readings, essays, problem-solving, seminars, works, reports, etc. to present or deliver in the theoretical classes, practical classes and/or small group tutorials.

The other Assessment Tools will not be modified with regards to what is indicated in the Course Guide.

Comments to the Assessment System:



- Concerning attendance, being online classes, attendance is not mandatory (although convenient) and mere assistance will not count in the final note. As a result, attendance is not recorded. The percentage of the expected score for mere assistance (10%) will increase the percentage of participation and favourable attitude in the subject (the percentage of the subject will be, therefore, in total, 40%). In other words, being the online classes will only take into account the participation of the student (besides, of course, the percentage corresponding to the practise and the exam) and the favourable attitude in the subject expressed by the student in the following ways:

1. The interventions of the students in the classes themselves (in-person or online), with the corresponding records or annotations.
2. Virtual tutoring through the UCVnet Virtual Campus or online sessions through Teams developed as a group or individual tutoring.
3. Interventions in the forum created on the UCVnet platform to raise and answer questions of the subject.
4. Emails or messages received raising questions about the subject.

However, in order not to harm students and to respect the corresponding percentages indicated in the teaching guides (following the academic report) as long as they have been applicable, the percentage corresponding to the mere attendance of the classroom teaching developed so far will be considered.

- About the final exam (to be carried out within the official exam period), it will be theoretical-practical and in writing. The exam will be two questions to develop theoretical-practical with an hour duration on the contents developed in the subject via UCV net platform.
