Observations

The written paper will consist of:

·Multiple choice questions with 4 possible answers and only one option. Each wrong answer will be deducted according to the formula: A- (E/n-1), in this formula A= hit; E= error, n= number of alternatives.

·Essay questions.

In order to pass the course it will be indispensable to obtain at least 50% of the value of the written exam (2,75 points). This criterion also holds for the second opportunity examination.

Practices will be carried out throughout the course in groups or individually, in person or by means of the University platform, as directed by the professor. **Deontological work** will be performed and delivered as indicated at the University platform.

Misspellings, grammatical inconsistencies that appear in texting language in tasks, examinations or other assessment tools, will suppose the loss of 10% of the score given to the exercise. This measure should be applied in all assessment instruments.

Students who on the first call, do not pass the written test for not reaching 50% of its value (2.75), must appear at the second call, reserving the notes of the deontological work, of the continuous assessment work made during the course and attendance and participation; the note that will appear to the students will be the one obtained in the written test over 10. Likewise, they will be able to carry out the works that they have not done during the course, having to adjust to the delivery date that will be indicated on the platform and that will always It will be before the written test of the second call

Students who have passed the written exam, but have failed the subject, will be able to present the works that have not been done during the course, having to adjust to the delivery deadline that will always be before the second call exam. to the written test, but it can be done, taking into account that the final grade will be the second call.

The student will enroll in a group S (suspended), which does not have teaching as such. The subject will be included in the semester that is taught in the ordinary group. Depending on the number of students they will be included in the tutorials and follow-up of the teacher of the ordinary subject or group tutorials will be carried out, contanting the students whit the responsible teacher through the Virtual Campus to indicate the days and hours of the corresponding tutorials.

The evaluation criteria will be the following:

- Written objective test: the same as that of the first enrollment students. With a value of 5.5.
- Presentation of 2 individual works that will be proposed by the teacher with a maximum value of 2.25 points each, and which must be delivered in the date indicated by the same and in the manner indicated on the University Platform.

Development of the subject for Exchange Students

The Erasmus / Mundus student enrolled in the subjects of the UCV degree in nursing, must send the professor of the subject an email / virtual tutoring communicating their situation. When a student who has been granted an ERASMUS / MUNDUS / SICUE mobility, plans to carry out their mobility in the second semester and has to take the second examination in any of the subjects studied, it will be the coordinator of course who marks the dates in coordination with the person in charge of the subject and the international coordinator. In these cases, the second calls will be held once the mobility period has ended and the students will know the dates before leaving for their destination country.

The evaluation criteria will be the following:

- Written test with the same content and on the same day as the rest of the classmates (if they have completed the mobility). If at the time of the exam they are still in an ERASMUS situation, they will contact the professor of the subject to specify an exam date.
- The work, practices and classroom activities will be carried out through the virtual campus, having the same evaluation criteria as the rest of their classmates.
- Attendance and participation will be evaluated according to the communication and interest shown by the student in the subject
- 2nd enrollment exchange students will follow the same criteria described for second and subsequent enrollments.

Mention of distinction

According to art. 22 of the Regulatory Regulations for the Evaluation and Qualification of UCV Subjects and RD 1225/2003,may be granted by the professor responsible for the subject to students who have obtained an "outstanding" qualification. The number of mentions that can be awarded may not exceed 5% of the students included in the same official record, unless it is less than 20, in which case a single mention may be awarded.

MENTION OF DISTINCTION:

According to Article 22 of the Regulations governing the Evaluation and Qualification of UCV Courses, the mention of "Distinction of Honor" may be awarded by the professor responsible for the course to students who have obtained, at least, the qualification of 9 over 10 ("Sobresaliente"). The number of "Distinction of Honor" mentions that may be awarded may not exceed five percent of the number of students included in the same official record, unless this number is lower than 20, in which case only one "Distinction of Honor" may be awarded.

Learning activities

The following methodologies will be used so that the students can achieve the learning outcomes of the subject:

- M1 Exposition of contents by the teacher, analysis of competencies, explanation and demonstration of abilities, skills and knowledge in the classroom.
- M2 Group work sessions supervised by the teacher. Case study, diagnostic analysis, problems, field study, computer room, visits, data search, libraries, network, Internet, etc. Significant construction of knowledge through student interaction and activity.
- M3 Supervised monographic sessions with shared participation.
- M4 Application of interdisciplinary knowledge.
- M6 Personalized attention and in small groups. Period of instruction and/or orientation carried out by a tutor with the objective of reviewing and discussing the materials and topics presented in the classes, seminars, readings, completion of assignments, etc.
- M7 Set of oral and/or written tests used in the initial, formative or summative evaluation of the student.
- M8 Student study: Individual preparation of readings, essays, problem solving, seminars, papers, memoirs, etc. To expose or deliver in the theoretical classes, practical classes and/or small group tutorials. Work done on the university platform (www.plataforma.ucv.es).
- M9 Group preparation of readings, essays, problem solving, papers, memoirs, etc. To present or deliver in the theoretical classes, practical classes, seminars and/or small group tutorials. Work done on the university platform (www.plataforma.ucv.es).
