Observations

ASSESSMENT CRITERIA:

In each of the written activities, the correctness of the use of language will be assessed. Spelling mistakes, grammatical inconsistencies and SMS language will result in the loss of 9% of the mark awarded in the respective assessment instrument.

The grade for the subject will be determined in the following way and is related to the practicum regulations:

1. Attendance:

The following aspects will be assessed:

- ·Seminars (R2, R6, R7): 15% -> If the student does not attend all the seminars, he/she loses the opportunity to take the questionnaire.
- ·Small group tutorial: 10% -> There will be three tutorials, if the student does not attend both, he/she will lose 10% of the final grade of the practicum.
- ·Clinical Rotation: 100% -> If 100% attendance is not met, the subject will be suspended, so it will be taken in the following courses.

2. Evaluation by the university academic tutor; this is equivalent to 40% of the final mark:

The following aspects will be assessed:

- Participation and evaluation of seminars 15% -> Participation in seminars is mandatory. For the qualification, the student will have access, if he/she has attended all the sessions, to 2 calls of a questionnaire that will evaluate the acquired knowledge.
- ·Final report of the Practicum: 15% -> It is a synthesis of the aspects related to the stay in the external center, where the student develops his experiences and establishes a care plan or an action protocol to be carried out in a specific situation. It is evaluated through a rubric (Annex I). It must be done directly from the platform, respecting the period and deadlines provided. For quality reasons it is important that the student follows this established format.
- ·Small group tutorials: 10% -> Small group tutorials are carried out with the academic tutor of the university and are mandatory.

3. Assessment by the tutor of the collaborating entity: this is equivalent to 60% of the final mark.

This evaluation is divided as follows:

- 1. Attitudinal evaluation and values 30%. Annex III
- 2. Skills and knowledge: knowledge and know-how 40%. Annex IV

The tutor of the collaborating entity evaluates through rubrics in collaboration with the nurses of each service or centre from the clinical rotation section and through the indicated platform. It is necessary to pass each of the assessment instruments in order to pass this section. In the event that the tutor of the collaborating entity requests the termination and/or expulsion of the student from the placement at the centre, the practicum will be considered completed and suspended and the application of the disciplinary regulations will be considered. In order to be able to add up all the assessment instruments, the student must fulfil 3 criteria:

- ·To have attended 100% of the external placements
- ·Have at least 2 points out of 4 points from the University Academic Tutor.
- ·To have obtained at least 3 points out of 6 in the evaluation of the Tutor of the Collaborating Entity.

In the event of failing any of the assessment instruments mentioned in the previous section, the student will fail. The published grade will be the grade of the highest assessment instrument. Therefore, the student will have to take the practicum the following year.

STUDENTS WITH ERASMUS, MUNDUS OR SICUE-SÉNECA SCHOLARSHIPS FOR STUDIES AND/OR INTERNSHIPS

The Nursing Degree encourages and promotes the international/national exchange of students. For this reason, work placements are structured and adapted according to the Practicum they undertake at the host university. If the student benefits from a study exchange or work placement, he/she must pay attention to the information provided by the host university, as he/she must adapt to the activities to be carried out there according to the subjects he/she is studying. If the student has not had to travel to the destination on the dates of the seminars, he/she can attend the seminars. If they are already at their destination, it is understood that they cannot attend the seminars. In any case, you must submit the Practicum report completed at the host university to: practicas.enfermeria@ucv.es. The evaluation will be determined by the grade obtained at the destination according to the activities carried out there. The criteria for Honours will be the same as for non-exchange students.

DEVELOPMENT OF THE SUBJECT IN SECOND AND SUBSEQUENT ENROLMENTS.

The assignment of the centre for the External Practicum will be carried out following the same criteria as for first enrolment students.

Students must register for the subject during the course.

The period and timetable for Practicum VII will be the same as for first enrolment students.

Evaluation criteria:

- The evaluation criteria will be the same as for first-time students. The seminars programmed in Practicum VII will have the same characteristics as those specified for first enrolment.

REVIEW OF GRADES

- •Academic tutor review: The academic tutor will carry out the review of the assessment instruments within the established deadlines.
- •External tutor review of the collaborating entity: The review of the centre's marks will be carried out by the tutor managing the practicum within the established deadline. <u>Students must not go to the placement centre to request a review of their marks.</u> In the event that he/she does go to the centre, the disciplinary regulations will be applied with the relevant sanction.

CRITERIA FOR THE HONOURS DEGREE:

In the case of internships, as long as the student obtains a 10 in the total mark, he/she will be eligible for an Honourable Mention. In the event of there being more students who opt for this mention than possible enrolments, an objective assessment will be carried out which the Nursing Practice Office will offer to the student/s concerned. The Honourable Mention will be awarded in order of the mark obtained in this objective test.

- •A. Description of the tasks carried out: In the description of the contents of this teaching guide, Level 1 and field 1 are mentioned. As well as level 2 and field classes. In this section of the final report, the student must relate the contents acquired in their external practicum to at least three of the nursing interventions developed according to the NIC Taxonomy Level 3 Interventions, including Field and Class (Level 1 and 2). During the practicum, a list of interventions is enabled on the intranet-practicum that the student must mark as they carry out (this list is corroborated with the TUTOR OF THE COLLABORATING ENTITY and the student's final report. The number of interventions marked on this list does NOT influence the student's evaluation).
- **B.** Assessment of the tasks carried out: The student must relate the competences of the teaching guide (general and/or specific) with the procedures carried out in the practicum and the theoretical subjects taken.

- •C. Relation of the problems posed and the procedure followed for their resolution: The student must mention the difficulties or small problems typical of a new unit, of the lack of knowledge of the procedures carried out, or even at an interpersonal level, as well as the procedure followed for their resolution.

- •E. Evaluation of the placement and suggestions for improvement: The student must respond to both aspects.
- •F. Specific evaluation of the practicum VII: All those data referred by the student that violate the confidentiality of personal data (initials, names, SIP, history number, box/bed, WHETHER REAL OR FICTITIOUS) will be penalized with a zero in the specific section of the evaluation instrument.

 - ·From the altered patterns, describe 2 NANDA nursing diagnoses, indicating R/C and M/P.
 - ·For each NANDA diagnosis, relate it to 2 NOC objectives, specifying the necessary indicators.
- ·For each NOC objective, describe 4 NIC interventions, from those marked in the Syllabus, detailing the necessary activities.
 - ·Develop a reflection of the case.
