Recommended knowledge

Learning outcomes

- R2 To acquire the capacity to relate the thematic blocks of the subject with the conceptual nuclei of the rest of the areas.
- R3 To know the basic doctrinal and documentary sources of Social Morality and Deontology for the different thematic nuclei.
- R4 To know how to analyse a specialised text and relate it to the thematic nuclei of Social Morality and Deontology.
- R5 Manage basic doctrinal and documentary sources according to the methodology of Social Morality and Deontology.
- R6 To be able to develop a topic according to the methodology of Social Morality and Deontology.
- R7 To resolve practical cases of morality in accordance with social moral teaching and Deontology.
- R8 To know how to dialogue with other moral and deontological proposals.
- R9 To know the different schools and ethical attitudes throughout history. To be able to apply these thoughts to the different aspects of modern society.
- R10 To read, understand and analyse the texts of the encyclicals with social content.

Observations

CONTINUOUS EVALUATION:

A minimum of 40% attendance to face-to-face classes is required to be eligible.

a. Written test (5 points)

It will consist of a written exam with essay or multiple choice questions that justify the knowledge acquired throughout the course.

b. Practical test (4 points)

The practical test will be carried out throughout the course in groups or individually, in person and/or through the platform, according to the teacher's instructions and the deadlines indicated on the University's platform.

c. Class attendance (1 point)

In order to be able to add up with the rest of the assessment instruments, a minimum of 40% attendance will be essential.

In order to pass the course, the student must pass the different assessment systems separately (attendance and active participation, practicals and exam).

FINAL ASSESSMENT

Students who, for justified and documented reasons, are unable to meet the minimum attendance requirements may apply for a single assessment. The request must be made in writing to the lecturer responsible for the subject, who will respond by the same means.

The single assessment does not consist of a single test, but of the set of tests and/or activities necessary to demonstrate and measure all the learning outcomes defined for the subject.

The structure of the single assessment in this subject will be as follows:

a. Written test

(60% of the total mark). Characteristics identical to those described in the continuous assessment.

b. Practical test

(40% of the total grade). This part will include a practical test, which may be oral or written, and, if



necessary, extraordinary autonomous work activities to demonstrate the learning outcomes that cannot be assessed by means of an exam.

In both modalities, students will have to pass all parts in order to pass the subject.

CRITERIA FOR CITACION AND ATTRIBUTION PRACTICAL EVIDENCE:

Any use of AI tools must be explicitly stated in the submitted document (e.g. in a footnote or annex).

The name of the tool, the purpose of use (e.g. grammar check, organisation of ideas, writing example) and in which part of the paper it has been used should be indicated. Responsible use of AI will be assessed as part of the criteria for originality and academic honesty.

Criteria for granting a "Honor" Mention: It shall be awarded to the students who have achieved a score equal or higher than 9.0. The number of mentions granted will not exceed 5 % of students enrolled in a subject in the corresponding academic year unless enrollment is under 20, in which case only one Distinction may be granted. (Royal Decree number 1125/2003)

To pass this class both in 1st or in 2nd call: the student must obtain a grade equal or higher than 50% in all items.

In accordance with the regulations governing the assessment and grading of subjects in force at UCV, the distinction of "Matrícula de Honor" (Honours with Distinction) may be awarded to students who have achieved a grade of 9.0 or higher. The number of "Matrículas de Honor" (Honours with Distinction) may not exceed five percent of the students enrolled in the group for the corresponding academic year, unless the number of enrolled students is fewer than 20, in which case a single "Matrícula de Honor" (Honours with Distinction) may be awarded.

Exceptionally, these distinctions may be assigned globally across different groups of the same subject. Nevertheless, the total number of distinctions awarded will be the same as if they were assigned by group, but they may be distributed among all students based on a common criterion, regardless of the group to which they belong. The criteria for awarding "Matrícula de Honor" (Honours with Distinction) will be determined according to the guidelines stipulated by the professor responsible for the course, as detailed in the "Observations" section of the evaluation system in the course guide.
