Se trata de posibilitar a los estudiantes la adquisición de conocimientos, competencias, información y práctica necesarios para el ejercicio del rol profesional en el ámbito de la Integración de Sistemas de Gestión. El estudiante estará apoyado tanto por un tutor académico o interno, como un tutor profesional o externo.

La Universidad Católica de Valencia tiene firmados diversos convenios de colaboración con empresas e institutos tecnológicos de la Comunidad Valenciana relacionados con la titulación para la realización de prácticas (ver listado incluido en apartado correspondiente al Criterio 7 de las presentes alegaciones), posibilitando así su futura integración en el mundo laboral.

Para llevar a cabo las Prácticas Externas, el estudiante estará apoyado por un tutor académico, quien llevará a cabo un conjunto de actuaciones a lo largo del período de prácticas que garanticen la calidad del proceso formativo y que estarán dirigidas a proporcionar a los alumnos las capacidades genéricas necesarias para su futuro ejercicio profesional.

La función del tutor es la de servir de orientador académico y apoyo institucional para el alumno en la realización de las actividades prácticas que realice. Además de las citas periódicas que se establezcan con el tutor/a, éste estará siempre disponible para los alumnos tutelados a través de las vías de comunicación con el profesorado existentes en la UCV (plataforma on line o tutorías presenciales).

Con el objetivo de guiar y tutelar al alumno durante las asignaturas de Prácticas Externas los tutores realizarán diferentes entrevistas y actividades formativas y de tutelaje que podrán ser individuales o con el conjunto del grupo tutelado.

- · Entrevista de orientación: En ella, el tutor orientará a los alumnos sobre las distintas opciones profesionales así como sobre los intereses, aptitudes, exigencias tanto de los alumnos como de las especialidades profesionales elegidas. Clarificará el sistema de evaluación de las Prácticas Externas y los pasos a seguir en la elaboración del trabajo/memoria de éstos, a presentar y entregar por parte de los alumnos.
- · Memoria del trabajo realizado en las asignaturas de Prácticas Externas: tras la finalización de las prácticas los alumnos presentarán una memoria escrita, que será evaluada por el tutor .
